### 1. Terms and Conditions

Information on how to enter this promotion and rules governing the conduct of this promotion are set out in these terms and conditions. Participation and submitting an entry in this promotion is deemed acceptance of these terms and conditions.

### 4. Conditions of entry

4.1. To enter the Iron Industry Gym BMW 320i lucky draw, you must:

- 4.1.1. sign up for a new 12 month gym membership, top up your existing membership for a further period of 12 months, or renew your expired membership for 12 months, at the promotional price of \$399 at Iron Industry Gym Chinatown or Iron Industry Gym CBD East or on our website [www.ironindustrygym.com.au](http://www.ironindustrygym.com.au);
- 4.1.2. complete and sign an entry form; and
- 4.1.3. pay \$399 at the time of signing the entry form.

4.2. The Iron Industry Gym membership for a new member commences on the date the entry form is signed. For existing members who top up an existing membership, the top up period will commence after the existing membership period expires. The purchase is final and cannot be refunded for whatever reason (including change of mind or at the conclusion of the promotion). The 12-month membership at the promotional price of \$399 cannot be extended or suspended for any reason.

## 5. How to enter

Step 1:	Sign up a new membership for 12 months, top up an existing membership for a further period of 12 months or renew an expired membership with Iron Industry Gym for 12 months at the promotional price of \$399.
Step 2:	Complete the entry form, pay \$399 and receive the unique lucky draw number.
Step 3:	A unique number allocated to your membership automatically enters into the draw.

## 6. Eligibility

- 6.1. Entry is open to South Australian residents only, 18 years and over.
- 6.2. Entry can only be made in an individual's own name and in his/her own capacity and no entry can be made for or on behalf of any other person, entity or organisation.
- 6.3. Employees, storeowners, and their families, as well as BMW South Australia staff, are ineligible to enter.

## 7. Iron Industry Gym's rights to reject and verify

- 7.1. You must complete all details requested on the entry form. Iron Industry Gym reserves the right to reject an incomplete, illegible or incorrectly completed entry form.
- 7.2. Iron Industry Gym reserves the right to verify the validity of all entries and disqualify or reject any individual entrant for tampering with the entry process, including but not limited to the utilisation of techniques designed to make multiple entries with a single gym membership or submitting an entry which is not in accordance with these conditions of entry.

## 8. Conditions of the BMW Lucky Draw

- 8.1. The lucky draw will only occur if 1,000 or more members (comprising new members who sign up for new 12-month gym memberships, existing members who top up existing memberships for a further period of 12 months, and former members who renew their expired memberships for 12 months) participate in the promotion during the promotional period.
- 8.2. In the event that there are more than 1,000 entries in the draw, the chance will be 1 out of the total number of entries in the draw.
- 8.3. There will be one winner of the prize. Every participant has a random, fair and equal chance of winning.
- 8.4. The prize must be registered in the sole name of the winner on the collection day.
- 8.5. Insurance cover will be provided up to the day of delivery to the winner, after this time, the insurance cover is at the discretion of the winner.
- 8.6. The winner cannot change the prize or exchange it for cash.

## 9. Additional Entries

- 9.1. There is no limit to the number of entries any person may enter.
- 9.2. For each entry, a 12 month membership must be purchased or if you are already a member, you refer a friend who joins and paid for a 12 month membership (ie. refer a

friend to join with \$399 membership fee paid by the friend = another entry to the lucky draw). The more you refer, the more chances of winning.

For example, if the participant joins the 12 month Iron Industry Gym membership and paid \$399 and referred a friend who also joins the 12 month Iron Industry Gym membership and paid \$399, the participant will receive 2 entries in total and the friend will receive 1 entry in total.

## **10. Transparency and Verification**

- 10.1. The number of participants in the draw will be displayed on a live counter on the Iron Industry Gym's website. Iron Industry Gym may also invite participants to join facebook dedicated for the lucky draw.
- 10.2. The draw will take place in front of an independent scrutineer and will be live-streamed.

## **11. Day of Draw**

- 11.1. The draw will take place at Iron Industry Gym CBD East (1/281-301 Pulteney Street, Adelaide SA 5000) or at the BMW Adelaide (36/40 West Terrace, Adelaide SA 5000).
- 11.2. Participants do not need to be present when the prize is drawn to win the prize.
- 11.3. All numbers allocated to the participants will be printed and placed in a transparent glass box on the draw date by an independent scrutineer. The independent scrutineer will draw the winning number on 4 December 2023 at 4pm.

## **12. Notification and Prize Collection**

- 12.1. If the winner is not present when the prize is drawn, the winner will be notified by phone and/or email within 24 hours of the draw and the initial of the winner's first name, last name and postcode will be published on the website [www.ironindustrygym.com.au](http://www.ironindustrygym.com.au) on 5 December 2023.
- 12.2. Iron Industry Gym will give the winner not less than 7 days written notification for the collection of the prize on the date and time to be nominated by Iron Industry Gym at BMW Adelaide (36/40 West Terrace, Adelaide SA 5000).
